1.Offshore overseas Chinese and foreign nationals who, pursuant to Article 4, paragraph 1, subparagraph 6 of the Regulations Governing Investment in Securities by Overseas Chinese and Foreign Nationals, invest in shares issued by TWSE Primary Listed, GTSM Primary Listed, and Emerging Stock Companies regulated by the Regulations Governing the Offering and Issuance of Securities by Foreign Issuers may do so by means of public tender offers. Those doing so shall furthermore comply with the provisions of the Securities and Exchange Act and the Regulations Governing Public Tender Offers for Securities of Public Companies.

2. This Order shall take effect from this day forward.
