Content :	 1.Pursuant to Article 3, paragraph 1, subparagraph 2 of the Regulations Governing Appointment of Independent Directors and Compliance Matters for Public Companies, an independent director of a public company, during the two years before being elected, may not have been a supervisor of the company. However, this restriction shall not apply if the independent director was an independently functioning supervisor serving pursuant to the provisions of Point 8 of the Standards for Determining Unsuitability for GTSM Listing under Article 10, Paragraph 1 of the GreTai Securities Market Rules Governing the Review of Securities for Trading on the GTSM prior to the 12 November 2012 amendment to those Standards. 2.
